INDIVIDUAL CONSULTANCY SERVICES TO UNDERTAKE DEVELOPMENT OF A COSTED IMPLEMENTATION STRATEGY AND PLAN FOR THE NATIONAL WATER POLICY AND BILL FOR UGANDA.

The Ministry of Water and Environment through the Directorate of Water Resources Management (DWRM) has acquired funds from Joint Partnership Fund (JPF) and intends to use part of the funds to acquire a Consultant to undertake development of a costed implementation strategy and plan, a regulatory impact assessment (RIA) report and ensure finalisation and submission of a revised National Water Policy and Water (Water Act amendment) Bill.

The overall objective of the assignment is to develop a strategic plan to guide Cabinet approval of the National Water Policy/Bill.

The scope of work for the Consultant will include but not be limited to:-

- support Consultations with national and sub-national level stakeholders on the content of the Policy and the Bill as well as salient issues that may have not been well captured
- develop detailed implementation and investment plan, and cost for operationalization of National Water Policy
- define mission, vision, values, objectives and strategy (SWOT analysis)
- define strategic priorities and action plans
- develop more effective communication and collaboration framework
- develop an effective internal evaluation mechanism
- propose a financial reporting system
- develop a sustainable fundraising strategy
- undertake stakeholder mapping and analysis
- In co-ordination with First Parliamentary Counsel (FPC) and in consultation with MWE, prepare Cabinet Memorandum based on the draft Water Bill for policy objectives of the Water Bill before submission to Cabinet
- Liaise with FPC/Solicitor General and Ministry of Finance, Economic Planning and Development to ensure issuance of a Certificate of Legal Compliance and Certificate of Financial Implications

The short listing criteria will include: An experienced and highly knowledgeable person on policy development process with a solid understanding of the Water Resources Management and Development Sub-Sector in Uganda, At least a Master's degree in the area of planning, public policy, development studies

and or water or any other relevant field to the assignment is a pre-requisite. At least five (5) years professional experience in strategic planning and management, prior working experience on fisheries and water in Uganda is an added advantage, demonstrated experience in working with Government partners and other stakeholders in public sector development programs especially in the area of fisheries and water, evidence of having undertaken similar assignments. The Consultant should also submit a Tax Identification Number (TIN) Certified Academic Documents and a copy of his/her National Identity Card.

The consultant will be acquired through publication of notice inviting expression of interest and developing a short list method set out in the PPDA Regulations, 2014.
